Event Ticketing/Reservations Terms and Conditions

Thank you for your interest in participating in Eclipse at the Point. Before you proceed to purchase tickets/reservations, we strongly recommend you review the following event ticketing/reservations terms and conditions:

- In this section, terms like "principal" and "responsible party" refer to you - the person who will make the reservation(s) to Eclipse at the Point. Similarly, "our," "us," "we," "issuer," "provider" and similar terms will indicate the organizers of Eclipse at the Point, Point Remove Events, LLC.
- By opting to purchase, allocate, or possess tickets/reservations to Eclipse at the Point, you automatically agree to our terms of use. If you have problems with any of the clauses listed below or do not agree with the risk allocations mentioned here, please do not purchase tickets/reservations or try to enter the Eclipse at the Point premises.
- Please note that Point Remove Events, LLC reserves the right to make changes, revisions, and amendments, or add/remove sections from this set of terms and conditions without any prior notifications to you. Such changes will be duly reflected on the website of the organizer (www.pointremoveevents.com). These changes will be retroactive to the date of your purchase of Eclipse at the Point tickets/reservations.
- The price of each ticket/reservation varies based on the type of campsite selected, the gear reserved, and/or type of reservation selected. This figure is non-negotiable.
- The ticket(s)/reservation(s) you purchase represents a revocable license for you to access the premises located at 755 Churchill Road, Atkins, Arkansas 72823 on April 4 through April 9, 2024, when Eclipse at the Point is scheduled to be hosted. This license can be revoked at any time by the issuer at its sole discretion without any prior notifications or compensation options. If the license is revoked, you will not be granted entry at the venue.
- The bearer must assume full responsibility for the Eclipse at the Point tickets/reservations, once (s)he receives them or confirmation of them. Point Remove Events, LLC has no liabilities--financial, legal, or otherwise--in case the delivered tickets are stolen, lost, damaged, destroyed or rendered unusable in any other way.
- Note that www.pointremoveevents.com is the sole authorized source for purchasing Eclipse at the Point tickets/reservations. If you obtain your ticket(s)/reservation(s) from any other source, you understand that those tickets may be either counterfeit or stolen. The issuer has the right to refuse to honor such stolen/counterfeit tickets and declare them as void.
- The Eclipse at the Point ticket(s)/reservation(s) delivered to you are not meant to be used for illegal reselling, copying, reproducing, or misrepresenting in any form. You cannot use the ticket(s)/reservation(s) for any promotional/advertising purposes (including sweepstakes and competitions) without our prior approval. Any proven record of such activities will result in immediate seizure and cancellation of your ticket(s)/reservation(s).
- Note that Eclipse at the Point tickets/reservations cannot be redeemed for cash, credits, or any other benefits.

- Point Remove Events, LLC has the right to investigate if there has been any violation of the Eclipse at the Point ticketing/reservation terms and conditions. In case of any conflicts, the decision of Point Remove Events, LLC will be deemed final (i.e., the issuer will remain the final arbiter in cases of disputes).
- The event service will be deemed to have been delivered in its entirety as soon as Eclipse at the Point ends on April 8, 2024.
- If you are not able to access any section(s) of the venue--the event premises described above--due to delays, federal/governmental regulations, organizer policies, weather-related problems, emergencies, venue shutdown/evacuation or any other reason, you will not be eligible for any refunds.
- All ticket/reservation sales are deemed as FINAL TRANSACTIONS. There will be no ticket/reservation returns, exchanges, or cancellations.
- Eclipse at the Point is a "rain or shine" event. The Solar Eclipse occurring April 8, 2024, is a natural occurrence and cannot be rescheduled. Therefore, no refunds will be issued for inclement weather.
- By purchasing the event ticket(s)/reservation(s), you automatically confirm that you are 18 years of age or older at the time of the purchase. If it is proven beyond doubt at the venue that the purchaser of the ticket(s)/reservation(s) is below this minimum age, (s)he will not be granted entry to Eclipse at the Point premises. No refunds, full or partial, will be issued.
- At the time of entering the event venue, you are required to produce a valid identification document (ID). By presenting an ID, you confirm that all details present on it are accurate.
- By purchasing Eclipse at the Point tickets/reservations and attending the event, you give your consent to Point Remove Events, LLC to collect certain information about yourself (name, address, picture, date of birth, gender, etc.) for verification and storage.
- You hereby agree to forego all types of surcharge claims - full or in part - and all claims & entitlements related to it.
- Point Remove Events, LLC does not take any responsibility for personal/financial damages incurred by you at the venue, or for any items lost, stolen, or misplaced at the venue. Financial reimbursement claims on these counts will not be entertained.
- Eclipse at the Point and Point Remove Events, LLC follow a common "zero-tolerance policy" towards unauthorized drug usage, carrying a firearm at the venue, and towards any type of behavior that can be interpreted as lewd or obscene. If you are found in possession of prohibited items at Eclipse at the Point and/or if you indulge in any objectionable action, your participation in the event will be terminated immediately. Your event ticket(s)/reservation(s) will be voided, and you will be asked to leave the premises.
- Note that you purchase Eclipse at the Point tickets voluntarily. As such, you do not have the right to initiate a chargeback claim or dispute with the provider of the credit card/debit card that had been used for the transaction.
- In all cases of disputes between the ticket/reservation bearer and the ticket/reservation issuer, the decision of the latter will be deemed final. In case a dispute cannot be resolved, the help of an independent third-party arbiter will be sought.
